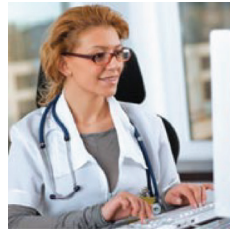
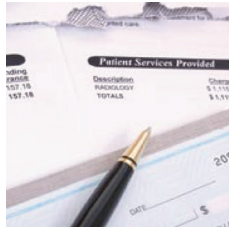

This all-payer solution automatically extracts detailed patient data from paper EOBs and consolidates that data with ERAs into a HIPAA-compliant 835 transmission for automatic posting. A digital archive provides online tools for researching claims, remittances and payments by any combination of multiple fields. HIPAA-compliant patient EOBs and reports can be viewed online, exceptions resolved, denials managed and secondary bills created.

Why Healthcare Lockbox?

Now that healthcare providers have the opportunity to use electronic remittance advices (ERAs) to reduce paper processing, the number of paper EOBs (Explanation of Benefits) is on the decline.

To continue reducing their posting expenses, healthcare providers now want to convert their remaining paper EOBs into ERAs and use a HIPAA-mandated file or the ANSI 835 ERA (835). Providers are seeking an all-payer solution in an 835 file that they can post automatically. Through a healthcare lockbox, they hope to reduce their manual posting costs and manage all their paper and electronic remittance transactions by consolidating them into a single data stream.

The healthcare provider benefits from increased productivity, enhanced customer service and reduced costs. More time is available to deliver quality patient care.

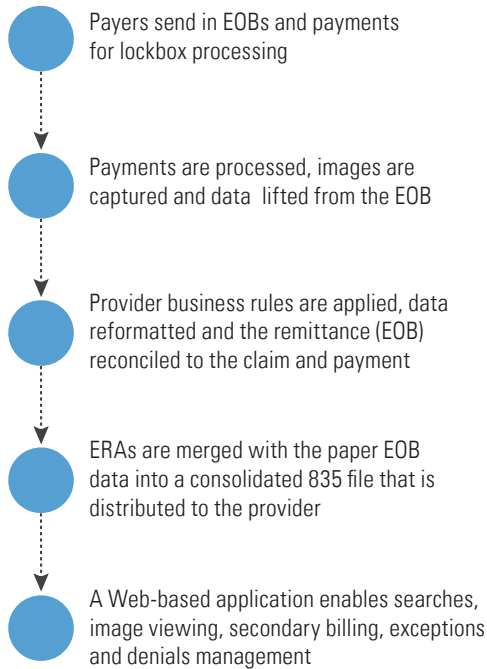
How Does RemitStream Healthcare Lockbox Capture Work?

The process begins with healthcare providers sending a copy of their original claims to our EOB processing facility to ensure efficient and accurate reconciliation. As payments are received from health plans, Fiserv processes them on our advanced equipment, capturing images of checks and EOBs.

Data is extracted from the EOBs via ICR (intelligent character recognition) technology. Low confidence characters are repaired, data verified, remittances matched to the corresponding claims and line items balanced to the check and batch totals. A HIPAA-compliant (835) transmission or proprietary file is created and transmitted to the healthcare provider or its clearinghouse within 24 hours.
