

1 Quarterly System Upgrades and Moratoriums

Throughout the year, Fiserv plans quarterly moratoriums for major system upgrades, if needed. The change window may require a four to six hour outage, depending on the service that is being upgraded. Clients and partners will be advised in advance, if Fiserv chooses to use any of the quarterly system upgrade windows.

3 Scheme Implementation Dates

Visa*, Mastercard* and eftpos have compliance windows twice annually to implement scheme-mandated changes. The schemes manage the change implementation – firstly, for their own central processing and secondly, for all processors and member financial institutions around the world. Some products and services provided by Fiserv may be impacted by these scheme mandates. For instance, clients may experience delays in the receipt of Direct Entry (DE) and General Ledger (GL) files on these implementation days. There will be no online service interruption. If there is any potential impact on processing, affected clients and partners will be advised in advance.
