Understand the Impact of Change

Funds Transfer Pricing and Profitability

Measure profitability at an account level including FTP, costs, fees and capital and provision. Aggregate to any dimension (customer/member or product) within the organization for consistent profitability. Calculate and report profitability at whatever level you choose with a complete, end-to-end solution to drive more-informed business decisions.

All-in-One Profitability Management

View profitability by instrument, branch, product, officer or customer/member. Capture profitability for all dimensions, down to the account level. Generate full profit-and-loss (P&L) reports for any dimension such as branch, department, product or officer. Process millions of transactions necessary to calculate P&L reports, even at the lowest level. Prepare shared service calculations to access efficiency of service-providing departments. Create a spectrum of analytical reports and analyses, including segmentation, ranking and aggregating data to the desired level.

Matched Maturity Funds Transfer Pricing

Perform detailed transfer rate calculations. Create and apply specific base rate and adjustment rate FTP rules and filters to accurately apply charges and credits such as liquidity premiums, options costs or management spread adjustment for any product, geographic or customer account attribute.

Fast Fact

Financial institutions have significant room for improvement in maximizing funds transfer pricing, with only half using FTP and just 57% of those using an instrument level, matched-term approach.


